#### **Panel Discussions take notes**

#### Panel 1: Connectivity & Digital Rights

This session mainly focussed on making youths aware of connectivity & digital rights specifically on what to do to ensure that there is connectivity and they got introduced on some of the projects in the country that aims at ensuring connectivity and how they can benefit. Some of those projects includes:-

- > The African Child projects which aims at bringing connectivity to schools
- ➤ The Kigamboni Community Network Innovation Hub which is an open space where youths can get free internet access to work on their innovations or project that will help solve challenges in the country.

#### Panel 2: Privacy& Data Protection, Cybersecurity, and Accountability

- > The starting point of cybercrimes is human therefore much of emphasis has to be kept so as to raise people's awareness on these issues.
- > People need to be safe even at an individual level
- > Its very important that people should use the multi factor authentications to protect themselves online.
- > The country should create a platform that will help the cybercrime or cyberbully victims get an immediate connection with the cyber experts when such incidents have occured.
- ➤ Its very hard to defeat social engineering there fore alot of things need to be kept in mind so as to be safe. For instance, being sure about the safety of a certain application before downloading
- > To avoid doing risky things whose consequences may be very dangerous downloading and using random VPNs
- > Religious groups and psychologist have to increase forces so as to raise awareness on cybercrimes and cyberbullies and how an individual can be safe.
- ➤ Lastly, Youths were encouraged to report any cybercrime/cyberbully they face so as they may get immediate help from experts.

#### Ice-breaker: Mr. Desmond Mushi - META

A specialist from META gave a short explanation on the future of the internet and how the emerging technologies are now slowing transforming the world.

The speaker also provided the youths with a list opportunities where they can learn and get exposed to those emerging technologies.

- ➤ The future Aprica VR Grants Program
- ➤ The Spark AR \ program
- ➤ The AR/VR Africa Metathon

#### Panel 3: Advanced Technologies including AI, IoT, and AR/VR

Within the next five years, we can expect AI and machine learning to become imbedded in all forms of technology that incorporate data exchange and analysis.

Some of the key points that were discussed in this session includes:

- ➤ How to tap into the opportunities in these emerging technology which will totally transform the world in the next 5 to 10 years to come.
- Opportunities for youths to learn AI/Machine learning and other emerging fields, Including.
  - The Datascience Scholarship at the University of Dar es salaam
  - The Annual 8 weeks machine learning bootcamp under Tanzania DataLab
  - Robotics for youths and Coding for kids who are below 12 years.
- ➤ Emphasis to youths having right skills set & creativity and how to invest on those skills.

## Presentation by Anja Gengo-UN secretariat:

Provided a brief introduction to Youth IGF and why youths IGF component of the ISOC was created and how youths can benefit from this component.
